## Merry Christmas!

My first Christmas at Faith Lutheran has been blessed with countless acts of kindness. From invitations to events, to cards coming in the mail, to beautifully wrapped gifts showing up in my office (often for Bea), my family has felt exceedingly loved this last month. I want to also thank the whole congregation for the generous gifts given to the church staff this year.
I am also grateful for your understanding and your prayers. Through some quirks of scheduling, Bea and I ended up with back-to-back procedures in the middle of December (good for insurance purposes, with the deductibles having been met, but really bad for a pastor's schedule...). Mine went as smoothly as expected. Bea's, alas, did not, leading to a second surgery right before Christmas. Throughout all of it, I appreciated the support of the church staff, Council President Bob Henry, members of my support committee, and countless others who checked in to make sure we were all right.

In the joyful and the terrifying, this was a December that will be remembered. But much of what we remember will be your all's kindness.

## Drop-In Hours:

This fall, in response to requests from a handful of congregants, I tried an experiment with "office hours" to see if they would be helpful to ministry. The results were mixed: initially people showed up during those times (especially the people who felt strongly that dedicated office hours are needed), before gradually they were used less and less. In talking to folks, one thing that I realized is that many people were confused about what "office hours" were meant to accomplish (note: they are not the only times I was in the office!).
This winter, I want to try a different experiment, namely "drop-in hours." These are times when I will be available for any parishioner who wants to talk about anything. It is part of a larger set of experiments in being creatively engaged in ministry (e.g. setting up a prayer station outside of the church in good weather, offering times for individual confession in Lent, etc.) that are on my agenda to try in 2024.
Often these drop-in hours will be in the office, but sometimes they will be elsewhere (like a coffee shop). I will publish information in advance. The purpose is to create times that do not have to be scheduled when someone can come for conversation or prayer. Outside these times, I am happy to schedule
meetings or visits, but sometimes it might be good to know that you can just "drop in." One thing that I want to emphasize, however, is that generally, you can always drop by when I am at the office or email/call me. Don't worry about "distracting me from other work." As a wise mentor once put it, real ministry is in the "distractions." Paperwork has its place, but the care of souls calls for gracious flexibility.

## Getting back to Acts:

I attended one of the Tuesday Bible studies on zoom a few weeks ago and was left pondering a story that we covered. The Bible study is working their way through the book of Acts, partly in response to my request that we focus on this book of the Bible in our common life over a 12-month period. The story in question is found in Acts 16. In the story, Paul and Silas are in Philippi and run into trouble with the local magistrates. Imprisoned, they spend the night singing and praying (and presumably using the time to evangelize others who are jailed with them). Suddenly an earthquake erupts, which shakes the foundations of the prison. It also breaks open all the doors...

Now this is what I have been replaying in my mind: if I were in that situation, how would I interpret the earthquake? Paul had been unjustly accused, mistreated, beaten, and jailed. In one sense, the earthquake could be seen as a sign of God's providence: setting the captive free. But Paul instead discerns that God has different intentions in the earthquake. Rather than liberating him from prison, the earthquake provides a power opportunity to witness to his faith in Jesus Christ. For when the jailer arrives, whose responsibility it was to keep the captives, well, captive, the jailer assumes that everyone has fled. His career is over. And he is overwhelmed with thoughts of suicide.

But Paul calls out, "Do not harm yourself, for we are all here" (16:28). Somehow Paul and Silas had discerned not only that God wanted them to remain in the prison but had also convinced (either directly or through their example) the other prisoners not to make a run for it. The jailer's life is not over! Instead, he receives a new life as a disciple of Jesus, and compelled by Paul's testimony, he and his entire household are baptized. The earthquake had literally broken the prison open, but God uses this not as a temporary fix for Paul's imprisonment, but as a chance to transform the life of the jailer and his family.

There is much to ponder in this story, my friends. About how we can expect trials and tribulations in our lives. About how sometimes life is not fair and how we may at times be mistreated. And then the evergreen wisdom that faced with great adversity, Christians respond by singing, praying, and testifying to God's grace! But more than that, this story has something to say about putting the needs of our neighbors, even our neighbors who persecute us, above our own immediate concerns. Leaving the prison would have been easy and no one would have blamed Paul or Silas for taking advantage of what surely appeared as a "God-given" opportunity. But in staying, the earthquake leads not to the death of one person (the jailer) but to new life for many.

Sometimes the obvious solution is not the right one. We can convince ourselves that "when God closes a door, he opens a window" and forget to ask whether God might really want us to stay in the room!

## Healthy Congregations

## What is "Healthy Congregations"?

Healthy Congregations is NOT a program itself, but a non-profit organization that offers resources, courses, workshops, coaching, etc. to help grow thoughtful leaders to strengthen faith communities. Pastor Dana has attended several of these offerings and at one time considered becoming a facilitator for the workshops that are offered to church congregations. Our church council felt that this organization may provide some excellent resources through some or all the six training workshops which are offered. The workshops are:

1. Creating Healthy Congregations
2. Healthy Congregations Respond to Anxiety and Change
3. Leadership in Healthy Congregations
4. Relationships in Healthy Congregations
5. Healthy Congregations Develop Generous People
6. The Spiritual Life of Healthy Congregations

Each workshop is made up of five sessions, and each session can be designed for 45 minutes to 90 minutes. Workshop One needs to be the initial workshop. The other workshops can be done in order or juggled in their sequence. There are a number of facilitators across the country who have been trained to provide the workshops and you can go online at "Healthy Congregations" to learn more about this organization.

The facilitator in our area who has agreed to provide the first workshop is Rev. Kevin Burney. He is an ordained Elder in the United Methodist Church and is currently serving as the Assistant to the Bishop at the Kentucky Annual Conference of the United Methodist Church in Crestwood, Kentucky. He has extensive training in teaching, counseling and pastoral care and has been a Facilitator for Healthy Congregations Workshops for many years.

Our intention (as the Council has suggested) is to offer the first workshop to our congregation, and
depending on the response and evaluation by attendees, to continue the series, or to conclude the program. Currently, we have scheduled the initial workshop for Saturday January 27 at the church, with a tentative schedule as follows:
8 AM: Open for participants to register (registration is free) and continental breakfast.
9AM: Workshop begins
10:30: Break
10:45: Program continues
12:30 Lunch (provided by Parish Life)
1:15 PM Program continues
3:30 PM Program concludes
This workshop is intended for all members of Faith Lutheran Church who would like to strengthen their commitment to the church and improve our Faith community. We know that a commitment to attend a workshop for a 5 -hour session is a big deal, but we trust the investment of time will be worthwhile. On behalf of the Council we hope that you will check your schedule, and if possible block this day off to attend this program.
